? Most of the world’s most industrialized nations have abolished execution as the top criminal punishment. The US, Japan, and Singapore are three notable exceptions.

? In 2010, a Florida crew of five criminals led by Jose David Diaz-Marrero stole some vases that contained what they believed were

crushed up pills. After snorting the substance, they later learned it was the ashes of a man and two great Danes.

? The Romans built the Mamertine Prison in the 7th century BCE as a place of temporary detention. The Christian saints' Peter and Paul were held there.

? Necrophilia is punishable by death in the Philippines, but due to legal loopholes, it's technically legal in many US states.

? Mohammad Ashan was a Taliban terrorist with \$100 on his head. In 2012, Ashan attempted to turn himself in to get the reward but was arrested instead.

? According to the FBI, Anchorage, Alaska ranked second among US cities in crime rate. The cold weather apparently doesn't keep the criminals in check.

? From 1986 to 2013, Christopher Thomas Knight (born 1965) lived as a hermit in rural Maine. He burglarized homes and camps occasionally, which is how he was eventually caught.
